Sir,

I am directed to inform you that the assessments to assess the standard of examination held by HNB Garhwal University, Srinagar (Garhwal), Uttarakhand and to assess the physical and the other teaching facilities available for recognition/approval of Shri Guru Ram Rai Institute of Medical Sciences, Dehradun for the award of MBBS degree granted by HNB Garhwal University, Srinagar (Garhwal), Uttarakhand against the increased intake i.e. from 100 to 150 seats u/s 11(2) of the IMC Act, 1956 were carried out by the Council assessors on 5<sup>th</sup> February, 2020 and 10<sup>th</sup> September, 2020. The assessment reports (5<sup>th</sup> February, 2020 and 10<sup>th</sup> September, 2020) alongwith the summary/observations of the member of the Undergraduate Expert Group appointed by the Board of Governors in supersession of Medical Council of India were considered by the Board of Governors in supersession of Medical Council of India and decided to recommend to the Central Government for Recognition/approval of Shri Guru Ram Rai Institute of Medical Sciences, Dehradun for the award of MBBS degree granted by HNB Garhwal University, Srinagar (Garhwal), Uttarakhand against the increased intake i.e. from 100 to 150 seats u/s 11(2) of the IMC Act, 1956.

The Board of Governors in supersession of Medical Council of India further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

- (2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."
